In order to establish CCR as **Center of Excellence**, UNICEF too has generously funded and rendered immense support so that CCR is set and established as a learning as well as excellence centre where rights and prerogatives related to children are discussed and children too find it easily and at front during their crisis hours. CCR has undertaken many activities where it has successfully conducted seminars, trainings and workshops for different functionaries related to law and allied fields referring to the rights and protection domain of children. The faculty members, especially the Chairperson at CCR works relentlessly with her unlimited zeal and vast experience in the field to cater to the needs of the desired audience. The student members too at the Center have helped and facilitated many local organizations for preparation of ready reckoners for police officers and modules on laws related to children besides acting as rapporteurs for State Level Meetings and Consultations. The team

of Technical Consultants too aim at executing the plans as per the desired goals and setting the stage to create this Center as Center of Excellence.

Internship Guidelines

With this initiative and zeal in mind, this time too, CCR proudly announces its call for second round of **online internship** for those interested and wish to contribute to Legal Research within the ambit of Child Rights and Child Protection. This internship is purely a research oriented task, revolving around the realm of Child Rights concern and shall be conducted virtually from home. Following are a set of rules that an intern is expected to follow while accepting this internship programme-

- The interns are bound to work from their respective homes and prepare and submit 05 case studies from their respective states as per the instructions from the Internship Coordination Committee.
- Each intern will present case studies pertaining to live examples and instances (famous case studies) from the field of Child Protection and Child Rights that have occurred or are occurring in India with particular reference to their state. The case study shall reflect the case from its initiation till date/ the present status of the case. It should be sustained with photos, newspaper clippings and creative writing as a content package.
- Live Case Studies of Child Protection and Child Rights in India shall be the prime focus of the internship programme. An intern shall be expected to present 05 topics in the form of case studies/ instances as a minimum 03 pager write up upon analysing which he/ she shall be marked selected for this internship programme.
- Another important criteria for selection lies in the fact that
 - State reasons as to why you inclined to work in the domain of child protection and child rights?
 - As stated earlier 05 case studies from the end of intern is a must.
- Each case study will be a minimum of 03 pages which will then be scrutinised and reviewed. The necessary changes need to be made by the intern in this first initial draft within the set stipulated period and then submit the second and the final draft.
- This internship programme is purely research oriented and individuals with the capacity of good writing skills and presentation would be preferred.
- The internship would run for a period of 30 days (01 Month) and only after the final report submission at the end of the stipulated time period, the internship certificate shall be provided.
- Any intern would be deemed to have completed the internship when she/ he acquires '15 unit points' within the set time frame. Unit points shall be assigned on the quality and not just quantity and the word count of the article submitted. The point allocation scheme is as described in the coming points.
